

Repeated payments

For the sale of Membership for 1/3/12 months through the web interface tixresell.com by the Seller – ZEAL Invest s.r.o. ID no.14178486, with a registered office at: Varšavská 715/36, Vinohrady, 120 00, Prague 2 (hereafter “Seller”) with your consent, which you give us by checking the appropriate box for consent to recurring payments directly in the order form, we as the Seller use recurring payments for selling Membership to 1/3/12 months (i.e. automatic debiting of payments from the credit card, the so-called recurring payments) for the duration of the Membership in the club. We use the Stripe payment gateway of Stripe, Inc. to make recurring payments. Recurring payments apply to all Membership options, please read these Terms thoroughly.

1. By checking the consent box, you agree to: establishment and parameters of the recurring payment (see below for details) and the storage of payment data on the Stripe payment gateway. Payment data, i.e. in particular credit card numbers and other data entered at the time of payment, are not shared with me and I do not have access thereto. Stripe, Inc. handles payment card data according to the international PCI-DSS Level 1 security standard (the highest level of data security in the payment card processing industry).

2. Common information for all recurring payments for each type of Membership and the option to terminate Membership:

1. Once you have agreed to a recurring payment as part of your first order for a specific Membership, I will email you a confirmation that the recurring payment has been set up within 3 business days. Until you terminate your Membership (or change it to another type), then always on the last day of the old membership period (i.e. for example, for a monthly membership it is the same day of the following month. For example: purchased on 20.6. so the next payment will be made on 20.7.) the membership payment will be automatically deducted (see below for specific amounts).

2. Unless you click the “cancel subscription” button at least 3 days before the end of the Membership (i.e., for example, for a Membership ending on a Friday no later than Wednesday), the Membership will automatically be renewed for the same period and the recurring payment for that period will be charged.

3. Recurring payment parameters: This is a payment for a monthly subscription (i.e. one calendar month). The payment is always deducted on the last day of the monthly Membership (i.e. 20.6. then 20.7. then 20.8. etc.) for the entire duration of the Membership, but if you do not receive at least 2 recommended actions in one month, you will automatically get that month for free (the payment will be postponed by one calendar month) (until you terminate the Membership – see paragraph 2.2.). A fixed amount of 65 € will be charged for each individual payment. If the price of Membership changes, you will be notified in advance by email and you will decide whether to continue or cancel your Membership. If you decide not to renew your Membership for another monthly period, you must click the “cancel subscription” button no later than 3 days before the end of the current monthly period. In case you notify me of the cancellation later, the next payment will be deducted and the

Membership will be extended by one month. The Membership and the recurring payment will then be cancelled.

1. Recurring payment parameters: This is a payment for a three-month subscription (i.e. three calendar months). The payment is always deducted on the last day of the Membership (i.e. 20.6. then 20.9. then 20.12. etc.) for the entire duration of the Membership, but if you do not receive at least 2 recommended actions in one month, you will automatically get that month for free (the payment will be postponed by one calendar month) (until you terminate the Membership – see paragraph 2.2.). A fixed amount of 165 € will be charged for each individual payment. If the price of Membership changes, you will be notified in advance by email and you will decide whether to continue or cancel your Membership. If you decide not to renew your Membership for another monthly period, you must click the “cancel subscription” button no later than 3 days before the end of the current monthly period. In case you notify me of the cancellation later, the next payment will be deducted and the Membership will be extended by one month. The Membership and the recurring payment will then be cancelled.

2. Recurring payment parameters: This is a payment for an annual subscription (i.e. one calendar year). The payment is always deducted on the last day of the annual Membership (i.e. 20.6.2020 then 20.6.2021 then 20.6.2022 etc.) for the entire duration of the Membership, but if you do not receive at least 2 recommended actions in one month, you will automatically get that month for free (the payment will be postponed by one calendar month) (until you terminate the Membership – see paragraph 2.2.). A fixed amount of 600 € will be charged for each individual payment. If the price of Membership changes, you will be notified in advance by email and you will decide whether to continue or cancel your Membership. If you decide not to renew your Membership for another monthly period, you must click the “cancel subscription” button no later than 3 days before the end of the current monthly period. In case you notify me of the cancellation later, the next payment will be deducted and the Membership will be extended by one month. The Membership and the recurring payment will then be cancelled.
